The Oversight Document History table in LGYHub is sortable. VA has migrated from the eBenefits Veteran self-service application to the VA.gov self-service application. Veterans may order their COE through VA.gov. This release provides value to the Veteran by providing an enhanced environment for self-service through VA.gov.
